Bosco was issued a misdemeanor summons for the offenses listed above. Bosco was released with a promise to appear in Torrington Court on 1/21/20.



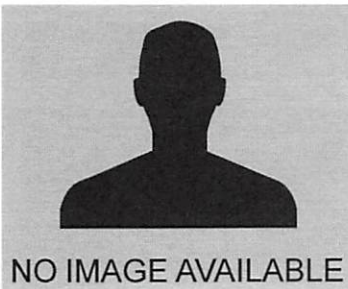
